MOU is valid for 3 years subject to renewal of yearly basis.


**Terms:**

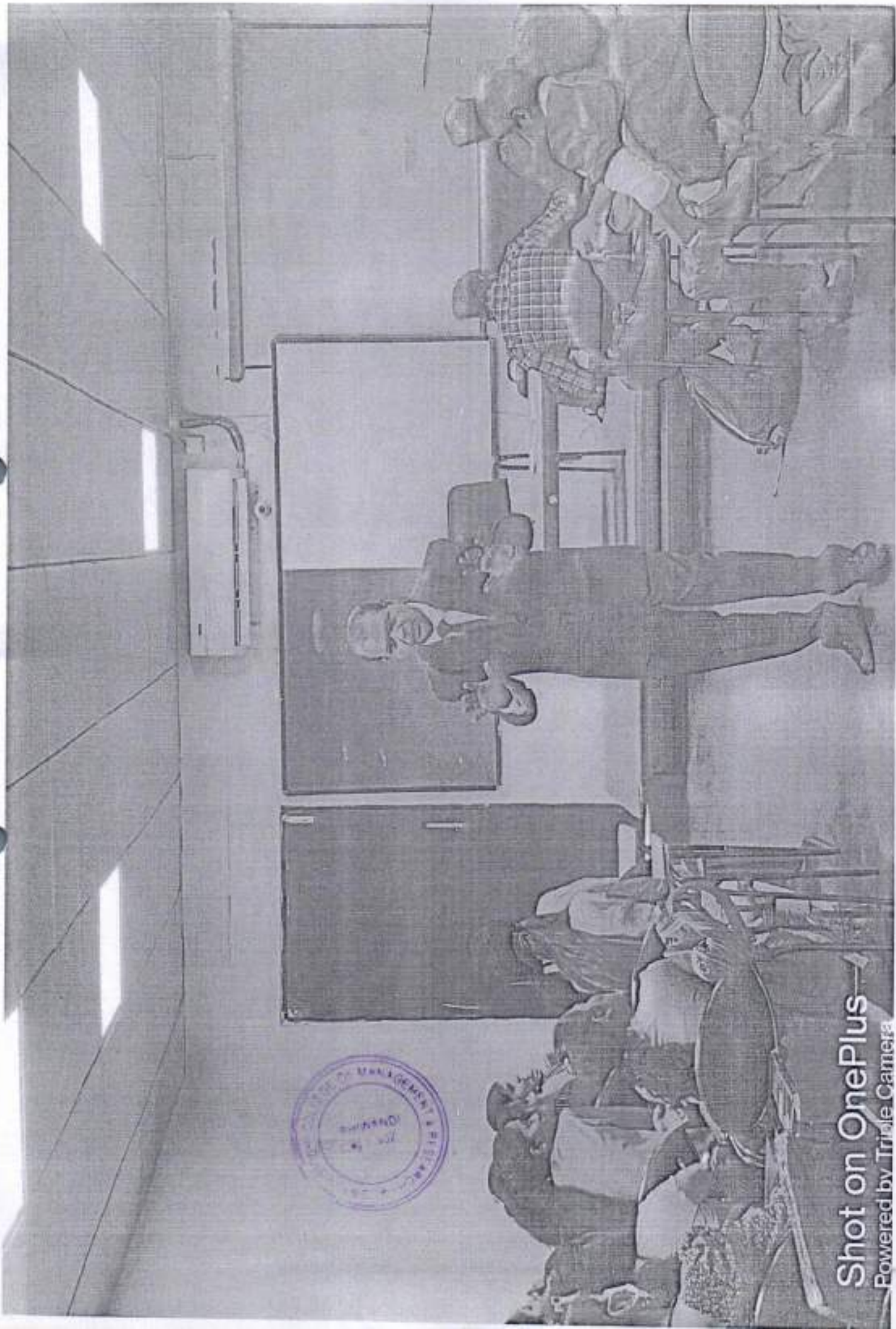


